1. Skokie Session - "Senior Teens" are welcome. These skaters should be at least 15 years old and if they are under 18 years of age, their coach will need to obtain advance permission for them to participate.
2. All participants must be USFSA members; contract ice and coupon skaters must be CFSC members. For information, contact Sandy Culver, Membership Chair at 847-549-1385

3. Walk-on skaters must join the club after 5 walk-on sessions.
4. Skokie contract fee may be paid in two equal installments; the balance is due January 2, 2011.
5. Coupons expire at the end of the Fall-Spring skating season and are non-refundable. Coupons are transferable.
6. Northbrook - 1 coupon / walk-on fee for each session (Session 1 = 2:30-3:30; Session 2 = 3:30-4:30).
7. All CFSC debts must be paid in full.
8. Members (and the parent/guardian of skaters under age 18) are financially responsible for all amounts owed to the Club, including the full price of Contract Ice. In order to be released from your obligation, you must submit written medical proof or proof of hardship to the Club. Only the Board of Directors can release you from your obligation.
9. The CFSC session manager will be available to answer questions and collect fees at all sessions.
